**Result Notice**

1. Department of Forests & Wildlife vide its Direct Recruitment Notice dated 27.12.2019 with closing date 16.02.2020 had advertised **11 vacancies (UR-04, SC-02, ST-01, OBC-03, EWS-01 and horizontal reservation for Ex-servicemen-01)** for the post of **Wildlife Guard/Game Watcher** in Department of Forests & Wildlife, Govt. of NCT of Delhi.
2. Department of Forests & Wildlife conducted computer based test for recruitment in respect of this post on 15<sup>th</sup> March, 2020.
3. Based on the performance in computer based test, **11 (UR-04, SC-02, ST-01, OBC-03, EWS-01 and horizontal reservation for Ex-servicemen-01) candidates have been provisionally selected** subject to correctness of the information furnished by the candidates in their online application forms. The marks of the last provisionally selected candidates in their respective categories, are detailed below:

4. The final marks obtained by **provisionally selected** candidates who have appeared in Computer Based Test are contained at **Annexure-1**.
5. The **provisionally selected** candidates shall be called for verification of certificates and other formalities separately. The candidates are hereby advised to check the website of the Department regularly.

6. Only those candidates have been considered in OBC Category, who have declared that they are OBC (Delhi) in their online application form.
7. **Further, since documents have not been called from the candidates along with the online application forms as such detailed scrutiny regarding eligibility has not been carried out, and therefore, mere inclusion of names in the list of provisionally selected candidates does not entitle them any right over the post.**
8. The selection of above candidates shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of the advertisement inviting applications and subject to thorough verification of their identity with reference to their photographs, signatures etc. on the application form, admit cards etc. The candidature of the above candidates are liable to be cancelled by the Department, in case the candidates are found not to be fulfilling eligibility conditions as prescribed in the RRs as well as terms and conditions of the advertisement inviting applications of the said post. The decision of the Department regarding the eligibility of the candidate shall be final and binding on the candidate.
9. While every care has been taken in preparing the result, Department reserves the right to rectify errors and omissions, if any detected at any stage.
